Foundation volunteers and board members also work with City, County, and State services to ensure that targeted assistance is available regardless of circumstance or location to all those in need.

Animal Welfare Program: The Foundation served over 150 families with pets by providing essential healthcare, food, fenced enclosures and rescue services for animals in need.
